



RECEIVE A MINIMUM OF \$100,000 OVER FOUR YEARS THROUGH ACCESS TO MSIDE+

Many families often experience sticker shock when they see the initial tuition price at Morningside, believing it to be out of reach. However, as a private university, we can provide a broader range of scholarships and grants compared to state colleges and universities, making Morningside just as affordable—if not more so—than public options.

Our commitment to making Morningside possible for more families through the Access to Mside underscores this goal. For the 2025-2026 academic year, new full-time undergraduate students can anticipate a BASE financial award package, which includes all available grants and scholarships, of \$25,000** for on-campus students and \$19,000** for commuter students. Additionally, Pell-eligible students* from Iowa, South Sioux City (NE), South Dakota, and Nebraska may qualify for further financial support.



TO QUALIFY FOR THE ACCESS TO MSIDE PROGRAM, YOU MUST COMPLETE THE FOLLOWING BY FEB. 28. 2025:

- Apply as a new, full-time undergraduate student for 2025-2026****
- Be admitted to Morningside University
- Visit campus
- Complete the FAFSA*

IF YOU MEET EACH OF THE ABOVE REQUIREMENTS, YOU WILL RECEIVE OUR BASE FINANCIAL PACKAGE:

- \$25,000/year if you are an on-campus or resident student**
- \$19,000/year if you are an off-campus or commuter student**/***

ARE YOU FROM NEBRASKA OR SOUTH DAKOTA AND PELL-ELIGIBLE?* IF YES:

- \$34,000/year if you are an on-campus or resident student**
- \$28,000/year if you are an off-campus or commuter student**/***

ARE YOU FROM IOWA OR SOUTH SIOUX CITY (NE) AND PELL-ELIGIBLE?* IF YES:

- \$38,000/year if you are an on-campus or resident student**
- \$32,000/year if you are an off-campus or commuter student**/***

[†]Only for first-time, full-time undergraduate students for 2025-2026 who live on campus and complete all qualification requirements.

^{*}Haven't completed the FAFSA? Not sure if you are Pell-eligible? The Morningside University Office of Student Financial Planning encourages you to complete the FAFSA to fully understand your aid options. If you have questions or require assistance with this process, please contact the Office of Student Financial Planning.

^{**}Students who take part in this program are strongly encouraged to complete the FAFSA each year to ensure you receive the maximum award, and Pell-eligible students must complete the FAFSA each year to ensure they remain Pell-eligible.

^{***}Students who are approved and choose to live off-campus prior to reaching 91 credit hours will receive \$19,000/year.
